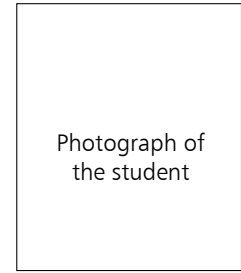

**Note:**

1. At present 50% discount is given on Normal Basic fare applicable to adult passenger. Discount is not applicable on Taxes. Passengers are advised to ascertain the applicable quantum of concession at the time of booking their ticket.
2. STUDENT' means a person who at the time of commencement of travel has reached his/her 12th but not the 26th birthday and who is enrolled for a full time course of at least one Academic year, at a recognized Educational Establishment. The student should not be employed either full time or part time or have regular income from any source except scholarships/ Stipends granted to them by Government or Educational Establishments.
3. Please note that only limited seats are allocated on each flight for rebated tickets, under the category 'STUDENT CONCESSION'. Hence confirmation of seats will purely be on first come first serve basis and no claims whatsoever will be entertained by Jet Airways in this regard.
4. The form shall be accepted only if it is verified and attested by the Principal/Head of the Educational Establishment.
5. This form is valid for issuance of tickets for three months from the date of attestation by the Head of the Educational Establishment.
6. GAURDIAN means legal guardian or a person acting in lieu of parents in the event of death or legal incapacity of parents.
7. HOME TOWN for the purpose of grant of student discount is the base of residence of the parents or guardian of the student as furnished by the student in their educational institution and as certified by its Principal.
8. EDUCATIONAL ESTABLISHMENT means, a School, College or University offering full time educational vocational, professional or technical courses of at least one academic year and shall not include a Commercial office, Industrial or Military Establishment or a hospital at which the student is serving as an apprentice unless such apprenticeship is a part of the curriculum of an educational establishment at which the student is enrolled.
9. ACADEMIC YEAR means a period of 12 consecutive months including whatever interruptions for vacations are normally granted by the educational establishment at which the student is enrolled.
10. The Educational Institutions must be recognized / aided by and / or affiliated to any of the following –
  - Central / State Government Educational Boards. • University • All India Council of Technical Education [AICTE] • Institutes recognized by Union / State Ministry. • Students of Indian institute of Chartered Accountants and Institute of Company Secretaries of India who are drawing a stipend of not more than RS 350 per month. • National School of Drama • Gentlemen / Lady Cadets of National Defence Academy and Indian Military Academy. • Students / Researchers of Shri Aurobindo International Institute, Auroville Pondicherry • Indira Gandhi Rashtriya Uradan Academy [Students Discount to the Trainee Pilots of this Academy will be offered only from the Airport nearest to the academy. The nearest Airport is only Lucknow.]
