

Prohibited articles

Acetylene Benzoyl peroxide solid or solutions, aerosol uninhibited aerosol products class A poison a, o, s. Air liquid non-pressurized aluminium diethyl monochloride, aluminium dross, wet arsine black powder bombs, explosives caps blasting, chloropicrin, absorbed, chloropicrin and methyl bromide mixtures chloropicrin and methyl chloride mixtures, cigarettes self lighting dispropyl-benzene hydroperoxide solution. Ethyl acrylate uninhibited explosive or explosives devices new, fire extinguisher charges fuzes, detonating grenade hand, or rifle, with bursting charge grenades, tear gas, hydrogen liquid, hydrogen liquid, hydrogen sulfide isopropyl percarbonate established isopropyl percarbonate unestablished. Restricted articles

Acetal, acetone, ammonium fluoride, argon, gaseous, arsenic acid solid barium chlorate benzene, borneol, calcium chlorate carbon dioxide gaseous or liquified, charcoal activated, chloroform, copper cyanide, crude oil, petroleum, diethylamine, ether, ferric chloride, formic acid fuel aviation turbine engine, helium gaseous, hydrochloric and mixtures, lead nitrate matches, safety (book card or strike box) malation, perfumes 'methonal, nitrogen gaseous and silver nitrate.'

The list of prohibited/restricted articles mentioned above is not exhaustive and is issued mainly for the guidance of the shipper. An exhaustive list may be seen in the "IATA DANGEROUS GOODS REGULATIONS" which is available at all our cargo booking offices; carriage of restricted articles their packing, labelling, certification, etc. shall be in accordance with the latest international air transport association's dangerous goods regulations.
