

Dear Sir/Madam,

This is with reference to the communication made in the month of February 2026 issued to present and former employees and workmen of Jet Airways (India) Limited (“**Corporate Debtor**”), in the matter of the orders of the Hon’ble National Company Law Tribunal, Mumbai Bench (“**NCLT**”), dated February 4, 2026, in the cases of *Manoj Kumar Das & Ors. vs State Bank of India & Ors.* (IA no. 3426 of 2025) and *S. Gopalakrishnan vs. Satish Kumar Gupta* (IA no. 4627 of 2025). A copy of the communication is also enclosed for your ready reference.

Kindly be informed that the Hon’ble National Company Law Appellate Tribunal, New Delhi (“**NCLAT**”), vide its order dated March 10, 2026, in the case of *State Bank of India and Ors. v. Manoj Kumar Das & Ors.* (Comp. App. (AT) (Ins.) Nos. 419 and 420 of 2026), has stayed the distribution of proceeds from the sale of the assets of the Corporate Debtor.

However, with a view to ensure correct details of former employees and workmen in an efficient and orderly distribution mechanism upon disposal of the aforesaid appeals, as recommended by a working group for the purpose comprising Authorized representative of workmen and employees, Head-HR of the Corporate Debtor and representative of EYRLLP (advisor to the Liquidator), the undersigned has launched an online portal (“**Information Portal**”) solely as part of an information-gathering exercise for the collection and verification of details such as current bank account details, copy of PAN card, copy of cancelled cheque, copy of Aadhaar card, Employee Declaration cum Undertaking for Gratuity Payment (“**Tax Undertaking**”), and other information as may be necessary for any future settlement of claims to eligible former employees/workmen of the Corporate Debtor, subject to applicable law and orders of the competent authority.

Employees/workmen are advised to submit the requisite information on the Information Portal at [9wemployeeclaims.unisparkinnovation.com](http://9wemployeeclaims.unisparkinnovation.com), as per the following schedule:

Last date for submission of information	31 <sup>st</sup> May 2026

Upon submission, a system-generated acknowledgement number will be displayed on screen. An email will also be sent to your registered email address upon successful submission. You may use this acknowledgement number to track the status of your submission.
