Constitution of the Stakeholder Consultation Committee (“SCC”)

This is in reference to the order of the National Company Law Tribunal, Mumbai, dated November 26, 2024, (“**Liquidation Commencement Date**”) which commenced the liquidation of Jet Airways (India) Limited (“**Corporate Debtor**”) and appointed Mr. Satish Kumar Gupta as the liquidator (“**Liquidator**”) of the Corporate Debtor.

Pursuant to his appointment, the Liquidator issued a public announcement on November 30, 2024 (“**Public Announcement**”) calling upon all the stakeholders of the Corporate Debtor to submit their claims as per Regulation 12 of the IBBI (Liquidation Process) Regulations, 2016 (“**Liquidation Regulations**”) as on the Liquidation Commencement Date. The liquidator has received claims from various classes of creditors, up to the last date of submission of claims as per the Public Announcement i.e. December 26, 2024.

As per Regulation 31 A (1) of the Liquidation Regulations, a stakeholders’ consultation committee (“**SCC**”) is to be constituted comprising of all creditors of the Corporate Debtor. As per Regulation 31 A (2) of the Liquidation Regulation, the voting share of a member of the SCC is supposed to be in proportion to his admitted claim in the total admitted claim.

For the constitution and participation in the SCC, each class of the stakeholders is required to nominate a representative on behalf of their entire class. Pursuant to Regulation 31A (3) of the Liquidation Regulations, the Liquidator will facilitate the process of nominating representatives to the SCC for each class of creditors other than the financial creditors.

However, considering the large number of claims received till December 26, 2024, being the last date of submission of claims pursuant to the Public Announcement, and the limited manpower available with the Corporate Debtor, the SCC (comprising of all the creditors / their representatives) will be constituted basis the claims which were received, admitted and crystallised during the corporate insolvency resolution process and the last updated list of creditors up to October 03, 2020. A copy of the list of creditors dated October 03, 2020 can be accessed from the website of the Corporate Debtor [Jet Airways](http://www.jetairways.com) (India) Limited). Pending verification, the different class of creditors for representation in the SCC is classified as per below table in accordance with Regulation 31A (3) of the Liquidation Regulations:

The verification of claims received up to December 26, 2024, is ongoing and upon the completion of verification process the Liquidator shall update the composition of the SCC along with the revised voting share.

Process of nominating a representative

- 1) **Annexure I** of this notice contains a list of stakeholders whose email-ID and/or registered address has not been received by the Liquidator. The stakeholders mentioned in the **Annexure I** are requested to fill in the details as required in this google form ([Email IDs not Available](#)) latest by January 22, 2025, at 6:00 PM.
- 2) The Liquidator will e-mail the creditors on the existing email IDs as available and received from the erstwhile resolution professional / available in the records of the Corporate Debtor / received by the Liquidator. For email IDs which are not available with the Liquidator, the process of nominating representative will be facilitated through an online e-voting agency portal once email IDs are provided by the creditors in the google form in para. (1) above.
- 3) The Liquidator will facilitate a process for nominations of authorised representatives for each class of creditors through an online e-voting agency (right2vote) portal.
 - a) Basis the responses received from the creditors in the google form mentioned in step 1 above, a link for nomination of the SCC representative will be shared by the e-voting agency with the creditors, on the updated email IDs shared by them.
 - b) The creditors shall receive an email from the e-voting agency containing the voting instructions at their email addresses. The creditors will have to open the e-mail where the confidential e-voting link is displayed. The creditors would then be required to click on the link after which a security enabled webpage will open where the voting matter will be displayed with the option to nominate the name of the person whom they would like to be represented by in the SCC, latest by January 24, 2025, by 4:00 PM. The e-voting module shall be disabled for voting at the close of voting period.
 - c) For the purpose of nominating the SCC representative for a particular class of creditors, the voting share of each creditor in a particular class will be calculated basis the % share of admitted claim of the respective creditor forming part of the total admitted claim of the creditors in their respective class of creditors.
 - d) As required under Regulation 31A (3) of the Liquidation Regulations, the Liquidator has facilitated the nomination process of the appointment of authorised representative through the e-voting agency portal mentioned above. The nominee who receives a majority basis the voting within the portal will be appointed as the representative for the particular class of creditors in the SCC.
 - e) As required under Regulation 31A (4) of the Liquidation Regulations, in case no nominee receives majority under the process mentioned in (d) above, then the representative for each class of creditors shall be appointed by a majority of voting share of the particular class, present and voting.
 - f) In the event the process mentioned in both (d) and (e) fails, the representative of the creditor, having the highest % share in the total admitted claim for the particular class of creditors will be deemed to be appointed as the SCC representative for the particular class of creditors, unless that particular creditor expresses their unwillingness to be appointed as the authorised representative. In such case, the representative of the creditor, having the second highest % share in the total admitted claim for the said class of creditors will be deemed to be appointed as the SCC representative.

Voting share of SCC representative

The voting share of the authorised representative appointed for matters to be voted upon in the SCC shall be in proportion of their total % of the admitted claims for the respective class of creditors they represent to the total admitted claims of the Corporate Debtor. It will be the responsibility of the authorised representative to get consensus on voting matters from the creditors of the class the authorised representative represents.
